Do any of the above on another account that you have with us.</li> </ol> <b>How long will the penalty APR apply?</b> If we increase your APRs due to a late payment, we may keep them at this higher level on existing and new balances until you make six consecutive on-time payments. If we increase your APRs for any other reason, we may keep them at this higher level on new balances indefinitely.	
<b>Paying interest</b>	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.	
<b>Minimum interest charge</b>	If you are charged interest, the charge will be no less than \$1.00.

<b>Transaction fees</b>	<ul style="list-style-type: none"> <li>• Balance transfer: <b>3%</b> of the amount of each transfer (minimum: <b>\$10.00</b>)</li> <li>• Cash advance: <b>5%</b> of the amount of each cash advance (minimum: <b>\$10.00</b>)</li> <li>• Foreign transaction: <b>2%</b> of each transaction in U.S. dollars</li> </ul>	
<b>Penalty fees</b>	<ul style="list-style-type: none"> <li>• Late payment: Up to <b>\$25.00</b> if your payment is late.</li> <li>• Returned payment: Up to <b>\$25.00</b> if your payment is returned for any reason.</li> <li>• Over-the-credit limit: None</li> </ul>	

**How we will calculate your balance:** We use a method called "average daily balance (including new purchases)."

**Loss of introductory rate:** We may end your Introductory Rate and apply the Penalty APR if you make a late payment.
