Annual percentage rate (APR) for purchases & balance transfers	0% Introductory APR for six months. After that, your standard APR will be 10.49%, 11.49%, 12.49%, 13.49%, or 18.49% depending on your credit history. This APR will vary with the market based on the Prime Rate.	0% Introductory APR for six months. Penalty APR and when it applies	23.49% This APR will vary with the market based on the Prime Rate. This APR may be applied to your account if you: <ol style="list-style-type: none"> 1. Make a payment that is late 60 days or more; 2. Make a payment that is returned; or 3. Do any of the above on another account that you have with us. How long will the penalty APR apply? If we increase your APRs due to a late payment, we may keep them at this higher level on existing and new balances until you make six consecutive on-time payments. If we increase your APRs for any other reason, we may keep them at this higher level on new balances indefinitely.	
Paying interest	Your due date is at least 21 days after we mail your billing statement. We will not charge you interest on purchases if you pay your entire new purchase balance by the due date each month. We will begin charging interest on cash advances and balance transfers on the date the cash advance or balance transfer is posted to your account.	
Minimum interest charge	If you are charged interest, the charge will be no less than \$1.00.
