



## **\$10,000 Aloha Sweepstakes**

### **OFFICIAL RULES**

**1. Eligibility:** The Columbia Credit Union \$10,000 Aloha Sweepstakes (Promotion) is open and offered only to legal residents of the States of Washington and Oregon age 18 or older as of July 25, 2023. Employees, Directors, and Supervisory Committee Members of Columbia Credit Union (Sponsor), affiliated and subsidiary companies; their legal advisers, advertising and promotional agencies, and suppliers for this promotion; as well as the immediate family (spouse, parents, siblings, and children, regardless of where they live) and members of the households of employees, Directors and Supervisory Committee Members (whether or not related), are not eligible. By entering, you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Void where prohibited.

**2. Promotional Period:** The Promotional Period has one Grand Prize drawing. The Promotion begins on July 25, 2023 at 9:00 a.m. Pacific Time and ends on September 29, 2023 at 6:00 p.m. Pacific Time (the “Promotional Period”).

**3. Prize/Odds:** One (1) person will receive one Travel Voucher (Prize) valued at \$10,000. The winner taking possession of the Prize is solely responsible for taxes. The Prize may not be substituted, transferred or exchanged. There are no other prizes. Odds of winning depend on the number of eligible entries received. If the winner cannot accept the Prize as stated, Prize will be forfeited and awarded to an alternate winner.

**4. Entry:** (i) Eligible person completes an official entry form at any Columbia Credit Union branch after the donation of a new, unwrapped toy for our Aloha Toy Drive by September 29, 2023. (ii) Eligible person must also be an owner of an open, active Columbia Credit Union checking account as of the end of our Promotional Period.

**No Purchase Necessary - Manual Entry:** A Participant may mail one 3”x5” notecard with name, address, email address and daytime phone number to: Columbia Credit Union, C/O “Aloha Sweepstakes” Promotion, PO Box 324, Vancouver, WA 98666 (“Manual Entry”). A Manual Entry for the Drawing must be received on or before the end of the Drawing’s Promotional Period. Only one (1) Manual Entry will be accepted during the Promotional Period.

A Participant may not enter with multiple identities including fictitious or assumed, nor may Participants use any other device or artifice to obtain more than the maximum number of entries. Any Participant who attempts to participate with more than one Manual Entry (including but not limited to using a fictitious name, assumed name, or uses any device or artifice to obtain more than the maximum number of entries) will be disqualified.

**5. Drawing:** At the conclusion of the Promotional Period, the Sponsor will compile all Entries and Manual Entries for the Friday, October 13, 2023 Drawing. The Sponsor will randomly select one Entry or Manual Entry as the Finalist for the “Aloha Sweepstakes” Drawing. If the Finalist is not a Manual Entry, the Finalist’s checking account must be confirmed open and active. If not, then another name as Finalist will be drawn and the same process will follow until one (1) Finalist is qualified. The Finalist must agree to and satisfy all conditions in section 6. If

not, then another name will be drawn and the same process will follow until one (1) Finalist accepts and satisfies the conditions in section 6. The Finalist who satisfies the condition of Section 6 shall be declared the "Winner". Winner does not need to be present at the Drawing to win. Winner will be notified on or about October 13, 2023, by phone or email and must respond within five (5) business days, or an alternate winner will be selected.

**6. General Conditions:** Winner must be able to verify he/she was 18 years of age as of July 25, 2023. Winner may be asked to complete, execute and return an IRS Form W9, a Liability Release, a Publicity Release prior to taking possession of the Prize. Failure to sign documents, or if Prize notification is returned as non-deliverable, or if Winner is found to be ineligible or not in compliance with these official rules, then disqualification will result and an alternate winner will be selected. By accepting the Prize, where permitted by law, Winner grants to Sponsor and those acting pursuant to Sponsor's authority (and agrees to confirm said grant in writing) the right to use and publish his/her name, biographical information, statements made regarding the Sponsor, or the Promotion (provided same are true), portrait, picture, voice and likeness for trade, advertising and promotional purposes without additional consideration, or notification, review or approval, worldwide, and on the Internet. If, for any reason, the Promotion is not capable of running as planned by reason of infection by computer virus, bugs, worms, tampering, hacking, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole opinion of Sponsor, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Promotion, Sponsor reserves the right at their sole discretion to cancel, terminate, modify or suspend the Promotion, and select the winner from entries received prior to the action taken, or as otherwise deemed fair and equitable by Sponsor. Arbitration/Choice of Law:** Except where prohibited by law, entrants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with this Promotion, or any prize awarded, or the determination of the winner shall be resolved individually, without resort to any form of class action, and exclusively by arbitration pursuant to the Rules of the American Arbitration Association then effective; and (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs

associated with entering this Promotion but in no event attorneys' fees; and (3) under no circumstances will entrant be permitted to obtain awards for and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.
