

# 2025 Holiday Event Gift Basket Drawing

presented by Columbia Credit Union

## OFFICIAL RULES. No Purchase Necessary.

**1. Eligibility:** 2025 Holiday Event Gift Basket Drawing presented by Columbia Credit Union (Columbia) is open and offered only to legal residents of the States of Washington and Oregon age 18 or older as of December 12, 2025. Employees, Directors and Supervisory Committee Members of Columbia (Sponsor), affiliated and subsidiary companies; their legal advisers, advertising and promotional agencies, and suppliers for this promotion; as well as the immediate family (spouse, parents, siblings and children, regardless of where they live) and members of the households of employees, Directors and Supervisory Committee Members (whether or not related), are not eligible. By entering, you agree to these Official Rules and the decisions of Sponsor, which are final and binding in all respects. Void where prohibited.

**2. Promotional Period:** Promotion begins on November 28, 2025, at 7:00 a.m. Pacific Time ("PT") and ends on December 12, 2025, at 11:59 a.m. (PT) (the "Promotional Period").

**3. Prize/Odds:** One (1) person will receive one (1) Holiday Event Gift Basket valued at \$300. The Winner taking possession of the Prize is solely responsible for any taxes at the fair market value of the Prize. The Prize may not be substituted, transferred or exchanged. There are no other prizes. Odds of winning depend on the number of eligible entries received. If a winner cannot accept the Prize as stated, Prize will be forfeited and awarded to an alternate winner.

**4. Entry:** Visit our community events during the promotional period, scan the QR code, and fully complete the online entry form. No purchase necessary. Limit one (1) entry per person. Entrants may not enter with multiple identities. Any entrant who attempts to participate with multiple identities to obtain more than the maximum number of entries may be disqualified.

**5. Drawing:** All entrants will be entered into a random drawing held at Columbia Credit Union's Operations Center in Vancouver, WA. Winner must also conform to and agree to all General Conditions listed in Section 6. If not, alternate Winner will be chosen until an eligible Winner accepts the General Conditions. Winner does not need to be present for the drawing. Winner will be selected on December 12, 2025, and will be notified by phone or email. The eligible recipient with have no more than five (5) business days to accept the prize.

**6. General Conditions:** Winner must be able to verify they were 18 years of age as of November 28, 2025. Winner may be asked to complete, execute and return an Affidavit of Eligibility, a Liability Release, and where lawful, a Publicity Release prior to taking possession of the Prize. Failure to sign documents, or if Prize notification or Prize is returned as non-deliverable, or if winner is found to be ineligible or not in compliance with these official rules, then disqualification will result and an alternate winner will be selected.
