

# Home & Garden Idea Fair Giveaway

## OFFICIAL RULES. No Purchase Necessary.

**1. Eligibility:** The Home & Garden Idea Fair Giveaway Drawing presented by Columbia Credit Union (Sponsor) is open and offered only to legal residents of the States of Washington and Oregon age 18 or older as of April 27, 2024. Employees, Directors and Supervisory Committee Members of Columbia Credit Union (Sponsor), affiliated and subsidiary companies; their legal advisers, advertising and promotional agencies, and suppliers for this promotion; as well as the immediate family (spouse, parents, siblings and children, regardless of where they live) and members of the households of employees, Directors and Supervisory Committee Members (whether or not related), are not eligible. **2. Promotional Period:** Promotion begins on April 27, 2024 at 9:00 a.m. Pacific Time (“PT”) and ends on April 28, 2024, at 5:00 p.m. (PT) (the “Promotional Period”).

Entry:** Visit the Home & Garden Idea Fair between April 27, 2024 at 9:00 a.m. Pacific Time (“PT”) and April 28, 2024 at 5:00 p.m., scan the QR code, and fully complete the digital entry form at [columbiacu.org/home-inspiration](http://columbiacu.org/home-inspiration). No purchase necessary. Limit one (1) entry per person. Entrants may not enter with multiple identities. Any entrant who attempts to participate with multiple identities to obtain more than the maximum number of entries may be disqualified. Single entry will be eligible for one of the three prizes listed above.

**5. Drawing:** All entrants will be entered into a random drawing held at Columbia Credit Union’s Operations Center in Vancouver, WA. Prizes will be drawn in the following order: 1) \$1,000 Home Depot Gift Card, 2) Big Green Egg Outdoor Grill, and 3) 2 Planter Boxes and a \$50 Yard & Garden Land Gift Card. Winners must also conform to and agree to all General Conditions listed in Section 6. If not, an alternate Winner will be chosen until an eligible Winner accepts the General Conditions. Winners do not need to be present for the drawing. Winners will be selected by May 3, 2024, and will be notified by email and phone. The eligible recipients will have no more than five (5) business days to accept the prize.
